JOB PURPOSE:

The incumbent is responsible for support the Policy Manager, International Security Relations in the development of security policies in respect of Jamaica's obligations to International, Regional and Bi-lateral conventions and agreements facilitating Jamaica's contribution to regional and international security.

The duties and responsibilities include but are not limited to the following:

- Researches, analyses and monitors developments on issues relating regional and international organisations in which the Ministry has an interest;
- Assists in the formulation of policies, position papers and other technical documents in accordance with international conventions, Memoranda of Understanding (MOU) and agreements;
- Organises and attends meetings between the Ministry and international missions and other regional or international organisations in Jamaica and overseas;
- Prepares responses to queries and questionnaires from regional and international organisations and partners as directed in collaboration with the Policy Directorate;
- Acts as a point of contact on international security in the Ministry and responds to general enquiries
 and information requests from regional and international organisations and missions in Jamaica, in
 collaboration with the wider Policy Directorate as required;
- Provides technical support to the Director ISR and Policy Manager as directed relating to other duties assigned which may involve organizations outside of the region/hemisphere;
- Assists in the proper documentation and storage of the documents produced by the International Relations Security and Organised Crime Unit;
- Participates in the preparation of operational plans, annual budgets and periodic reports;
- Performs other related duties as assigned.
